- I understand that certain risks of injury are inherent in my participating in the game of baseball, and, having full knowledge of such risk, I voluntarily assume them of my own accord.
- I agree to hold - my team and its sponsors; MWB and its officials, sponsors and fields owners; officials; and all participating communities and their representatives - harmless of any responsibility, financial or otherwise, due to any injuries received while playing, practicing or traveling to and from events or while participating in any league or association activity.
- I, for myself, my heirs, executors and administrators, hereby voluntarily release, forever discharge and agree to indemnify and hold harmless the above team and organization (MWB and their officials) from any and all claims, demands or causes of action which are in any way connected with my participation an any MWB activity or my use of MWB equipment or facilities including such claims which allege negligent acts or omissions of MWB.
- Should MWB and its officials or anyone on their behalf be required to incur attorneys fees and costs to enforce this Agreement, I agree to indemnify and hold them harmless for all such fees and costs.
